



Secure warranties

The following warranty information is intended as an overview only. For complete detailed warranty coverage and eligibilities, refer to Freightliner and LifeLine warranty booklets. The Freightliner extended warranty increases the warranty by three or five years at an additional cost. Cost varies with ISB or ISL engine models.

Warranty details

TWO-YEAR, UNLIMITED MILE WARRANTY

LifeLine warrants your vehicle for two full years starting at the day of delivery to Purchaser. (If an on-board diesel generator is supplied, the warranty limit on the generator is two-years, or 1,000 hours, whichever occurs first.)

If the vehicle or its components should fail during normal use, LifeLine will, free of charge, provide parts and labor to make a repair to the component so that the vehicle and components are in good working condition. Repairs may require the Purchaser to drive the vehicle to a service location within 200 miles of their location so that repairs can be made effectively by factory-authorized service agents. The Purchaser understands that most repairs must be made at factory-authorized agent locations.

If a defect is found in normal business use, LifeLine will, at its election, repair, provide a replacement part or product, or make appropriate adjustment.

Damage to a product caused by accident, misuse, or abuse is *not* covered by this warranty.

LifeLine is *not* responsible for other consequential costs. In no event shall the liability of LifeLine exceed the purchase price of the component, nor does LifeLine's warranty cover incidental costs that Purchaser may endure, such as lost days of use, lost program income, under-utilized labor costs, or any other incidental cost.

THE FOREGOING WARRANTIES ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

LIFELINE DISCLAIMS ANY LIABILITY FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES. This warranty is to the original consumer purchaser only, and excludes product damage due to installation error, product abuse, or product misuse, whether performed by a contractor, service company, or the Purchaser.

EXTENDED WARRANTY IS AVAILABLE AT EXTRA COST FOR THE DRIVER CAB-CHASSIS UNIT UTILIZING A FREIGHTLINER-CUMMINS CHASSIS-FRAME (\$100 DEDUCTIBLE)

Basic coverage is for 2-3 years or 150,000 miles. Extended coverage available at extra cost, as outlined on front. Deductible applies to extended coverage. Following is a list of component coverage under the extended warranty program from Freightliner:

ENGINE

Covered parts: All internally lubricated parts, water pump, water outlet, manifolds, block, cylinder heads, flywheel and ring gear, crankshaft, damper, oil pan, valve covers, timing gear, chain and front cover assembly, seals/gaskets, fuel injection system (including throttle body assembly, lines and nozzles), turbo-charger, oil passage plug, freeze plugs and governor.

Examples of engine parts not covered: Ignition wires, coil and spark plugs, glow plugs and wires, filters, hoses, drive belts, thermostat, fan and shroud, fan clutch, radiator, engine tune-up, normal maintenance, oil cooler and lines, air compressor, air and vacuum pumps, air cleaner, engine mounts, exhaust system, external fuel oil lines and pipes.

TRANSMISSION

Examples of transmission parts not covered: Transmission mounts, shift linkage, oil cooler and hoses, filters and fluid.

FRONT AXLE AND SUSPENSION

Covered parts: Axle I-beam, king pins, bushings, bearings and seals, steering knuckles, leaf springs, U-bolts, stabilizer shaft, linkage and bushings.

Examples of front axle parts not covered: Shock absorbers, tie rods, steering arms, brackets, spacers and cushions, bumpers, wheel alignments and balancing.

REAR AXLE, SUSPENSION AND DRIVE LINE

Covered parts: Leaf springs, stabilizer bar, equalizing beam and bar, torque rod, bushings and links, U-bolts, front and rear axle housing units and all internal parts, carrier propeller shafts and center support, yokes, flanges, U-joints, axle shafts and bearings, seals/gaskets.

Examples of rear axle parts not covered: Shock absorbers, cushions and bumpers, spacers and brackets.

INSTRUMENTS

Covered parts: Instrument cluster assembly.

Examples of instrument parts not covered: Radio, heater, a/c controls, horn and horn relay.

CLINIC AIR CONDITIONER AND POWER GENERATOR

Basic coverage is for two years, unlimited miles. Extended coverage not available.
